

Pennsylvania Land Trusts Expand Conserved Lands by 58% in Just Eight Years

Although land trusts have been protecting Pennsylvania's special places since the mid-20th century, their work has accelerated dramatically in the new millennium. The 2011 census of PA land trusts found that the past eight years account for 37% of the acreage ever conserved by land trusts. Conducted biannually by the Pennsylvania Land Trust Association, this latest census found that between January 1, 2004 and December 31, 2011, Pennsylvania land trusts:


- protected 80 acres per day;
- protected 233,182 acres in total, the equivalent of 2.5 cities of Philadelphia;
- increased the acreage protected by conservation easements by 88%;
- increased the acreage owned in fee by land trusts by 118%;
- increased the acreage reconveyed to governments by 35%; and
- increased the number of conservation easements by 106%.

Acres protected in 2004-11 compared to all prior years




Land Trust Accomplishments in the Last 8 Years

58% gain in total acres conserved by PA land trusts over 8 years








Land Conserved in Pennsylvania

- Pennsylvania land trusts have protected a total of 637,636 acres of land in Pennsylvania.
- 5.6 million (20%) of Pennsylvania's 28.7 million acres enjoy some degree of conservation protection.
- Land trusts have protected 11% of the total lands protected.
- Land trusts have protected over 2% of Pennsylvania's total land area.

Land Trust Accomplishments

Conservation Easements

- Sixty-five land trusts hold a total of 2,957 conservation easements in Pennsylvania, protecting a total of 219,370 acres.
- The average land trust-held easement is 74 acres.
- Thirty-five land trusts completed 124 conservation easement transactions in 2011.


Acquistions

- Seventy Pennsylvania land trusts own 79,415 acres in fee.
- Twenty-seven land trusts completed a total of 51 land acquisitions in 2011.

Land Reconveyance

- Thirty-one Pennsylvania land trusts have reconveyed a total of 338,430 acres to governmental entities.
- 9,303 acres have been reconveyed from land trusts to other types of non-governmental organizations.
- Land trusts, through reconveyance to governmental entities, have helped protect 7% of lands held by government.

Spotlight on Easements

Subdivision of Easements

If landowners exercised every right available to subdivide their properties and transfer parcels into separate ownerships, land trusts reported this would result in 3,544 independently owned parcels that they'd be responsible for monitoring.

Of the 52 land trusts that submitted easement data for the 2011 census, thirty-one responded to this question. To the extent that the 21 non-reporting organizations do not track the number of potential ownerships that they may someday have to deal with, PALTA sees this as a potential problem with planning for future stewardship.

Easement Amendments

Thirteen Pennsylvania land trusts reported completing 19 easement amendments in the year 2010 alone.


Easement Violations

Over 5 years, ending in 2010:

- 10 Pennsylvania land trusts reported 11 major easement violations.
- 24 Pennsylvania land trusts reported 499 minor easement violations.

Land Trust Supporters

Pennsylvania land trusts have over 128,500 members/financial supporters.

- 63% of Pennsylvania land trusts reported 100 or more members/financial supporters.
- 31% of Pennsylvania land trusts reported 500 or more financial supporters.
- 20% of Pennsylvania land trusts reported 1000 or more financial supporters.
- 10% of Pennsylvania land trusts reported 2000 or more financial supporters.
- Pennsylvania land trusts have a median average of 250 financial supporters.

Notes:

Determining what characteristics define a "land trust" is tricky as was determining what organizations to include and exclude from this analysis. Some level of subjectivity is unavoidable. PALTA endeavored to exclude from the analysis on this page:

- organizations that have not yet acquired a parcel of land or easement;
- organizations for which ownership of one or a few property interests appears to be an aberration -- a situation largely unrelated to present purposes;
- organizations that in the past acquired one or more property interests but do not appear to now have conserving additional lands, if they were to become available, as part of their mission; and
- organizations that appear to own land only to advance a specific purpose and the purpose appears to be satisfied (for example, a private nature center that has no plans to conserve additional lands).


